

JOINT RISK MANAGEMENT

Humanitarian organisations operate in volatile contexts and are exposed to diverse risks. A robust risk management mechanism can minimise their impact.

The focus of this training will be on risks related to safety and security as well as how to implement and maintain a comprehensive risk management system together with partner organisations. On the basis of the Circle of Security, participants will discuss how to conduct a context analysis and a risk assessment, how to reduce the impacts of the identified risks and how to formalise them in Standard Operating Procedures (SOPs). They will also get familiar with contingency planning and the monitoring of their risk management.

The training consists of four online sessions. Each session will be composed of a mix of theory, individual and group exercises as well as practical examples and open discussions. During and between the sessions, participants will work on own case studies to practice the seminar learnings in their own work.

The training is tailored at staff of German and local humanitarian NGOs that are responsible for proposal writing, the implementation of humanitarian projects and/or security-related topics in their organisation without prior knowledge on risk management. In the registration form it is possible to make two registrations with one booking. We kindly ask German NGO colleagues to forward this invitation to their local partner organisations and to coordinate on a joint registration if they wish to work on a common case.

The sessions will be facilitated by Jacob van 't Slot and Steven Poot from Global Risk Advice, a Dutch consultancy that offers security and crisis management training and advisory to local, national and international NGOs.
